Welcome to our 2025 Kite Festival!

The WSIKF Committee will assign all spaces, prioritizing a first-come basis whenever possible. A complete list of **all items** for sale—starting with the primary item or product—along with pricing, *must* be submitted with this application. Only **approved** items may be sold—**no exceptions.**

To ensure variety, no more than **two vendors** will be approved to sell the same type of food or product. It is essential that you list all products you intend to sell. Failure to comply may result in immediate cancellation of your space **without refund.**

All vendors must provide **proof of insurance.** Food vendors must have a **current Food Handler's Card** and a **Pacific County Health Permit.** All vendors are also responsible for providing their own garbage cans.

Applications will be accepted until **July 31st, 2025**, and space assignments will be announced by **August 11th, 2025.**
